FMSCA/DOT – CSA2010. Given the carrier/driver safety rating changes required by MSCA/DOT, the Allen Lund Company will conduct monthly investigations within the FMSCA site to confirm carrier/driver ratings, and take necessary steps to remove carriers not rated at a level in keeping with ALC standards. - Carriers must have SMS scores well below the “At Risk” category
- Carriers are also reviewed via Carrier 411 and TIA websites, for complaints
