# **Scholarship Agreement**

The following sets forth an agreement between Florida SouthWestern State College (hereinafter "FSW Foundation") located at: 8099 College Parkway Fort Myers, Florida 33919 and the Bobby Nichols Fiddlesticks Charity Foundation (hereinafter "Fiddlesticks Foundation", Located at: 15391 Canongate Drive Fort Myers, Florida 33912.

### I. GIFT

The Fiddlesticks Foundation will make a minimum contribution to establish an endowed fund within the FSW Foundation, to be known as, the Earl Holland Memorial Scholarship Fund. The permanently restricted Earl Holland Memorial Scholarship Fund scholarship awards will be funded by the interest derived from total of all gifts received.

- 1. All FSW scholarship recipient(s) must submit the following to be eligible: Application for Admission, Official High School Transcript(s), Florida Residency Affidavit, Free Application for Federal Student Aid (FAFSA), and an FSW Online Scholarship Application.
- 2. The applicant must be a US citizen or meet the requirements of an eligible non-citizen as defined by the Federal Financial Aid Program.
- 3. The applicant must have obtained an unweighted 2.0 or higher High School Grade Point Average. (GPA); or a college/university GPA of 2.5 or higher.
- 4. The applicant must enroll in a minimum of twelve credit hours per semester
- 5. The applicant must provide one letter of recommendation from any of the following organizations.
  - a. Liberty Youth Ranch, Bonita Springs, FL
  - b. ACT, Abuse Counseling and Treatment, Fort Myers, FL
  - c. Children Advocacy Center, Fort Myers, FL
- 6. To be eligible, applicant must score at or above the test scores provided below on either the Postsecondary Education Readiness Test (P.E.R.T) or the students ACT/SAT scores.
