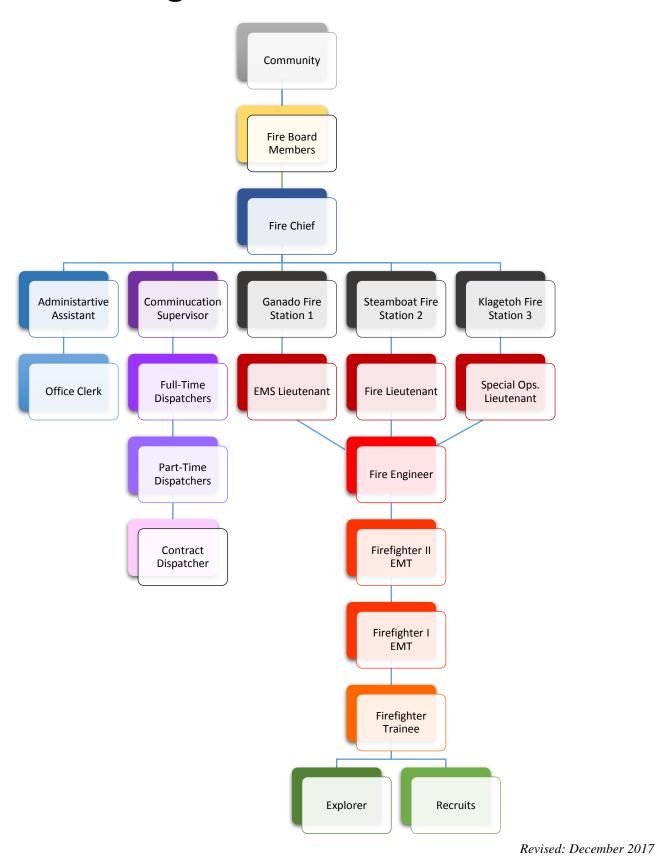

REVISED GFD ORGANIZATIONAL CHART

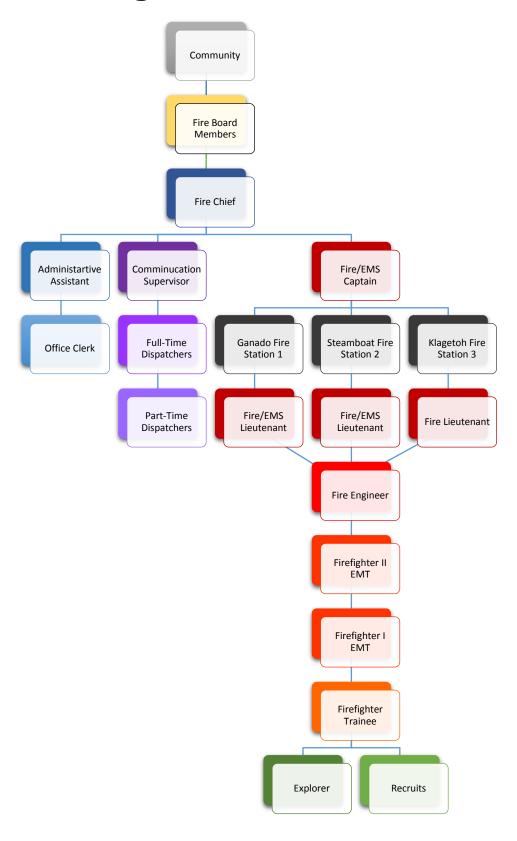
