### **About IASA**

The Illinois Association of School Administrators is the premier advocacy organization for school administrators in the state. Since 1946, the IASA has offered Illinois school administrators the opportunity to join with colleagues throughout the state to improve the quality of public education in Illinois and to maintain the high standards of their profession.

To encourage networking, the state has been divided into 21 IASA Regions. Each region schedules regular meetings at the local level. Each region also selects or elects individuals to represent their region on the IASA Board of Directors and to serve as representatives on IASA's five representative committees. IASA is a state-chartered association of the American Association of School Administrators (AASA). The two associations work cooperatively in a number of endeavors to serve the needs of members in the local, state and national arenas. IASA members are encouraged to join the AASA and to become active members in its programs and services, but dual membership is not a requirement.

The IASA is involved in many things from child advocacy to lobbying, and from publications to professional development programs. However our main goal is individual member care and service, including personal counseling and mentoring as well as access to confidential contract and credential reviews.

### **Executive Director's Note:**



When we look back on FY2018, I think it will be remembered as one of the better years for public education in the last decade if not several decades. Within the calendar book ends of the year, we saw the evidencebased model (EBM) for public school funding pass into state law and we saw it funded with over \$650 million for the first two years of its existence. ## **Member Benefits**

The IASA membership continues to hold steady with more than 1,050 active members and close to 1,700 total members, including over 600 retired members, school service members and full-time professors. The IASA welcomed 75 new superintendents for the 2017-18 school year. While two of these individuals transferred from another state, 73 rose through the ranks of the Illinois public school system. The association provides valuable member benefits and services that school administrators need day-to-day in their decision-making and leadership guidance roles in the school districts in which they serve. IASA is the state's premier advocacy organization supporting leaders in the pursuit of educational excellence through continued school improvement.

#### **Field Services Directors**

IASA Field Services Directors Dr. Gary T. Zabilka, Dr. William H. Phillips, Tim Bleyer, and Ralph Grimm provide a wide array of services ranging from mentoring new superintendents to providing group and one-on-one assistance to superintendents. The IASA Field Directors also assist superintendents with resources, training and relevant member services.

#### **Personal Services**

No report on the programs and services would be complete without mentioning the personal services provided to IASA members. These services, though well known by the members, are not reported in any specific detail in order to protect the confidentiality of those members who access these services. For example, the executive director and administrative team are just a phone call away to assist members who need guidance in matters ranging from issues of school administration and communications issues to matters concerning individual employment contracts.

#### Legal Support & Return of Dues

The Legal Support and Return of Dues programs assist members during times of intensive personal and professional stress. The IASA Legal Support Program works in concert with and independently from the AASA legal assistance program. The legal support to qualifying members, in cases of employment contract/due process disputes with employers, is in the form of direct access to IASA Associate Director/Legal Counsel Sara Boucek and/or private counsel through a formula-driven financial reimbursement of private attorney fees.

Further, IASA continues to provide the Return of Dues Program to its members. This program is a self-funded insurance program

that reimburses the estate of a deceased member, the regular and/or retired dues paid to the Association for the most recent 10 consecutive years. The Return of Dues Program lapses in the 11th year of retirement. Both programs (legal support and return of dues) operate within the financial parameters set many years ago, that of being funded from interest earned by the fund accounts.

#### Job Bank

The Illinois Education Job Bank<sup>sm</sup> continues to expand in use by both employers and job seekers, and is the leading Internet educational job posting service in Illinois. More than 750 Illinois school districts and 275 other educational institutions are utilizing the Job Bank's services. In cooperation with the Job Bank<sup>sm</sup>, the IASA Interim Education Service Corps provides retired members access to full-time, part-time and interim education employment opportunities.

#### **Professional Development**

IASA offers a wide array of Administrators' Academies, workshops and seminars under the direction of Associate Director for Professional Development Dr. Richard Voltz. The professional development opportunities include such topics as teacher and principal evaluation, board-superintendent relations, school law, school finance, leadership, curriculum, technology, and communications.

During 2017-2018, IASA presented 10 workshops/academies serving approximately 5,875 attendees.

#### Aspiring Superintendent Academy

The IASA Aspiring Superintendent Academy (ASA) is a weeklong academy designed for administrators seeking to become a superintendent. Each day includes sessions dealing with topics on School District Leadership, Communications Strategies, School District Planning and Operations, School Finance, Advocacy and Law and Action Planning and Next Steps. Since the program launched in July 2016, there have been over 70 principals, assistant superintendents and other central office school administrators attend this weeklong boot camp. The next Academy is scheduled July 9-13, 2018 in Springfield at the IASA headquarters.

#### **New Superintendent Services**

The New Superintendents' Conference was attended by 52 superintendents in August of 2017. The conference is designed to provide resources on many of the issues that new superintendents will face during their first year. In addition, "New Superintendent Updates" are e-mailed to new superintendents as well as any other













superintendent who wishes to sign up. Simply call the IASA office to receive the update directly. The update is also posted on the IASA website for all members. These updates cover a variety of topics and include some helpful tips that are both relevant and timely.

#### **IASA Mentoring Program**

During 2017-18, IASA provided mentors to 65 new superintendents. We are pleased to provide first year superintendents with this service at no cost.

#### IASA School for Advanced Leadership

Eleven years ago, an idea was pitched to create a learning opportunity for Illinois superintendents and was initially billed as the University of IASA. Eight years ago, that idea began to be transformed into a plan and was soon named the IASA School for Advanced Leadership (ISAL). On December 3, 2010, the initial ISAL class gathered at the IASA headquarters in Springfield to start the maiden voyage of what we believe has been a superior learning experience. The program culminated in August of 2012 with the graduation of 23 ISAL fellows, a talented and diverse group of school leaders that underwent a rigorous two-year immersion into adaptive leadership learning experiences accompanied by highly trained coaches.

At this point in time, four ISAL classes and a total of 98 ISAL fellows have successfully completed the two-year cohorts. The ISAL IV cohort was launched in January of 2017 with 25 members graduating in May 2018. The IASA School for Advanced Leadership continues to accomplish its mission by providing quality professional development for practicing superintendents in unique and challenging ways. The two-year ISAL cohort includes:

- A professional coach;
- Developing a personalized professional growth plan for student achievement; and
- Conducting a comprehensive needs assessment to determine district and leadership needs.

ISAL also studies the superintendent's role through five leadership lenses: facilitator of shared moral purpose, change agent, relationship/culture promoter, capacity builder, and coherence maker.

Applications for ISAL V are being accepted through October 12, 2018. Interested superintendents needing more information can contact ISAL's Co-Facilitators, Dr. Nick Osborne and Dr. Gary Zabilka.

#### Communications

Members have direct access to Mary Schaefer, Director of Communications and Marketing and Jason Nevel, Assistant Director of Communications for consultation and assistance in developing talking points, media statements or messages to parents. In addition, IASA's online monthly magazine, *Leadership Matters*, is one of IASA's main communications vehicles. The magazine includes messages from IASA Executive Director Dr. Brent Clark as well as stories about innovative, successful programs from peers throughout the state and issues important to public education in Illinois.

#### Legislative Advocacy

IASA provides a full-time Director of Governmental Relations, Diane Hendren, to track legislation in the General Assembly and advocate on behalf of our members. Timely updates and political analysis are provided to members through Capitol Watch reports. Lobbying activities are coordinated with the other members of the Illinois Statewide School Management Alliance, including the Illinois Association of School Boards, the Illinois Principals Association and the Illinois Association of School Business Officials. Members also receive a guide to members of the General Assembly and constitutional officers as well as meetings and seminars with elected and government officials.

In addition, the Alliance Legislative Report continues to be delivered via e-mail. It offers a straightforward report on bills affecting public education.

#### Networking Opportunities with Colleagues

The IASA Annual Conference is held in the fall and the Alliance Leadership Summit is held in February of odd-numbered years. In addition to national-level speakers and professional development opportunities, these events offer unique opportunities to network with colleagues from around the state. Monthly region meetings offer regular opportunities to communicate with peers about timely issues common to educational leaders.

#### **IASA Annual Conference**

The IASA Annual Conference offers members the opportunity to hear from nationally known speakers as well as participate in breakout sessions and other professional development opportunities. The 2018 Annual Conference is scheduled for September 26-28 at the President Abraham Lincoln Hotel and The BOS Center.

#### Alliance Leadership Summit

The biennial Alliance Leadership Summit is held in February of oddnumbered years. It is designed for school administrators, school board members, school business officials and principals to gather to strategize, discuss issues and visit with legislators. The 2019 Alliance Leadership Summit is scheduled for February 26-27, 2019 in downtown Springfield.

## **Other Programs**

#### The Alliance

In the Spring of 1993, the executive directors of the four statewide educational management associations-Illinois Association of School Administrators, Illinois Association of School Boards, Illinois Association of School Business Officials and Illinois Principals Association-solidified discussions concerning joint efforts, including but not limited to legislation, and formed the Illinois Statewide School Management Alliance.

The Alliance structure allows the four associations to pool their resources and personnel, thus presenting strong, unified positions on education issues before the Illinois State Board of Education, Illinois General Assembly, and Office of the Governor. Under the umbrella of the Illinois Statewide School Management Alliance, the executive directors of the participating associations coordinate several programs in areas including school finance, insurance, energy, and professional development. Continued improvements in the Alliance relations are achieved through the practice of focusing on matters of mutual interest with respect for each of the Alliance partners' need to maintain autonomy.

#### The Illinois Energy Consortium

The Illinois Energy Consortium, a joint energy-purchasing consortium sponsored by IASA, IASB and Illinois ASBO, provides utilities to Illinois school districts at lower costs. It is the Midwest's largest energy purchasing pool. The IEC board consists of the executive director and three representatives from each of the sponsoring associations. #### ISDLAF+

The Illinois School District Liquid Asset Fund Plus ("The Fund") offers a variety of opportunities to school districts for the investment and management of funds, which includes school districts and community colleges in Illinois. Since its inception, ISDLAF+ is the only investment program sponsored by three separate benchmark associations: IASA, Illinois ASBO, and IASB. Each recognizes the fund as being powerfully and uniquely suited to the needs of Illinois school districts—providing the ideal mix of safety, liquidity, and yield. #### P-Card

The P-Card (Procurement Card) Program continues to grow each year. A popular benefit of the program is the rebate that is given

to each participating school district. Rebate amounts are based on the total volume each school spends. In addition, the P-Card streamlines the purchasing process, reduces the purchase order paperwork, increases budget and internal controls, provides better reporting, and reduces the cost of making monthly payments to vendors. While it looks like a credit card, the P-Card does not have a revolving monthly credit. The balance is paid in full every month. #### Environmental Consultants, LLC "Tools for Schools"






## IASA Membership Growth Since FY 2000:

## **Governing Board and Committees**

IASA accomplishments are always tied to the commitment of the IASA Governing Board members working as both individuals and leaders of the various IASA Committees. The Governing Board is the primary decision-making body of IASA, consisting of members of the 21 regions and up to two at-large representatives.

IASA has three Super Regions: Northcentral, Northeastern, and Southern. Each consists of seven IASA Regions from which the IASA Governing Board rotationally elects the IASA President. A map indicating the boundaries of the 21 IASA Regions and three Super Regions is included on page 26 of this report.

Dr. Thomas E. Bertrand of Rochester Community Unit District #3A (Northcentral Super Region) served as President for the 2017-2018 year, with Dr. Sheila Harrison-Williams of Hazel Crest District #152-5 (Northeastern Super Region) becoming President on July 1, 2018 for the 2018-2019 year. Paula Hawley of Pikeland CUSD #10 (Southern Super Region) was voted President-Elect and will become President on July 1, 2019.

In the event that a Super Region has no candidate for the position of president-elect in any given year, the rotation would then pass to the next Super Region in the rotation. The Super Region that declined to put forth a candidate would be eligible for the election of a president-elect during its next turn in the rotation. For the purpose of running for and holding presidential offices of the IASA, a member's Super Region will be determined at the time of the election. Should a member move from the Super Region during the time of serving as the IASA President-Elect, President, or Immediate Past-President, it will have no impact on office eligibility.

**The Governmental Relations and Advocacy Committee** (GRAC) continues to function as the legislative workhorse of the Association. Before being brought before the Governing Board for adoption, the GRAC reviews and develops the resolutions and position statements. A current list of the IASA Resolutions and Position Statements are posted on the IASA website. On the federal legislative front, IASA coordinates with the AASA Legislative Corps.

**The IASA-ISBE Advisory Committee** meets regularly with the State Superintendent of Education and members of the ISBE staff to discuss and review matters of educational policy and programs. The Professional Development Committee is a hands-on, working committee that designs and develops the IASA professional development programs and activities. Even though legislative activities continue to take a high profile position within the IASA, there continues to be a significant amount of activity and need in the area of professional development. In 2007, the Professional Development Committee made a recommendation to the Board of Directors to establish the "Dr. Walter H. Warfield and Dr. Jacob S. Broncato AAC Scholarship" and allow each region to award one scholarship annually. The recipients of this scholarship can attend one IASA Administrators' Academy Credit course at no cost, which will help to ensure that they meet the requirements for certificate renewal.

In addition to offering courses throughout the school year, the IASA School of Professional Development also offers courses as early bird sessions at the IASA Annual Conference and a special session at the Joint Annual Conference.

Established activities for new superintendents continue to be well-attended. Based on the numerous comments in letters, phone calls and e-mails, the weekly mailings to the new superintendents have also been well-received. IASA continues to work regularly with the IASB, Illinois ASB0 and IPA to meet the professional development needs of its respective members. A guiding principle for the work done here is not to duplicate programs that would compete for the limited time and money administrators have to spend on professional development.

The Membership and Communications Committee's focus is on communications and public relations and the recruitment and retention of members in all of the IASA membership categories. Special emphasis remains on all active, school service and new superintendents. As the IASA communications outreach program continues to grow, this committee will serve as a resource and focus group for staff.

Although not required, joint membership in AASA is also encouraged. Within the AASA governance structure, Illinois is being represented by five members on the AASA Governing Board.





## **IASA Bylaws**

As adopted November 25, 1967 and amended through October 2, 2015.

**ARTICLE I-PURPOSE** 

The purpose of the Association shall be to conduct conferences, provide in-service education programs and promote education.

ARTICLE II-OFFICES

The Corporation shall maintain in the State of Illinois a registered office and a registered agent at such office and may have other offices within or without the State.

#### ARTICLE III-MEMBERS

SECTION 1. CLASSES OF MEMBERS. The Association shall have six classes of members. The designation of such classes and the qualifications of the members of such classes shall be as follows:

- A. Active Member. Active Member status is available to an individual who is employed in Illinois as:
  - i. A school administrator in a school system or an educational cooperative of school systems and contributing to the Teachers' Retirement System; or
  - ii. An administrative staff member of the Illinois State Board of Education or the Illinois Association of School Boards, provided such person has previously worked as a school administrator; or
  - iii. A superintendent or assistant superintendent of a regional office of education.

Persons qualified as school administrators who are not currently employed in that capacity may be deemed eligible for Active Member status by the Board of Directors.

Active Members hold all the rights, privileges and responsibilities of the Association, including the right to vote and the right to hold office.

- B. Full-Time Professor Member. Full-time Professor Member status is available only to full-time professors of education or educational administration at an accredited institution of higher education in Illinois and carries the rights to receive regular mailings of the Association and participate in the IASA Return of Dues Program.
- C. Associate Member. Associate Member status is available to an individual who is actively pursuing a career in school administration and is not eligible for Active Member status. Associate Member status carries only the right to receive the Association newsletter.
- D. Retired Member. Retired Member status is available to a person who has retired from the profession of school administration and who was an Active Member at the time of such retirement and carries the right to receive the annual Association directory and the Association newsletter.
- E. School Service Member. School Service Membership shall be available to: manufacturers and distributors of school materials, supplies and equipment; architects; legal firms; publishers of school textbooks and related materials; and to other such businesses that provide services to Illinois schools. School Service Members shall be entitled to regular mailings of the Association newsletter, to inclusion in the annual Association directory as a School Service Member, to a copy of the annual Association directory, and to other services that provide such members with access to Illinois school administrators who are Association members.
- F. Student Member. Student Member status is available to a person who has not achieved certification as a superintendent, has a master's degree, and is currently enrolled as a graduate student in a recognized program in school administration. Verification of such status must be made by a full-time professor of education or educational administration in Illinois at the college in which the student is enrolled, who is a member of the Association. No one may hold Student Member status for more than three years. Student Member status carries only the right to receive the Association newsletter.

SECTION 2. VOTING RIGHTS. Each Active Member shall be entitled to one vote on each matter submitted to a vote of the members.

SECTION 3. DUES. The minimum annual dues for the Active membership classification shall be .007 of the gross annual salary. Each March, the multiplier for the following year shall be calculated based on the total Active Membership and increased by .00025 for every 25 Active Members fewer than 1,052.

The annual dues for the following membership categories are established by the Board of Directors and contained in the IASA Policy Handbook: Full-Time Professor Member, Associate Member, Retired Member, School Service Member and Student Member.

SECTION 4. MEMBERSHIP YEAR. The membership year shall be July 1 through June 30.

SECTION 5. TERMINATION OF MEMBERSHIP. Membership shall continue until terminated by any one or more of the following circumstances:

- A. Non-payment of dues;
- B. Formal written resignation by the member; or
- C. Action by the Board of Directors.

#### **ARTICLE IV-MEETINGS OF MEMBERS**

SECTION 1. ANNUAL MEETING. There shall be one annual meeting of the Association each year. The Board of Directors shall determine the time and place for the meeting.

SECTION 2. SPECIAL MEETINGS. Special meetings of the members shall be held as the Board of Directors deems necessary.

SECTION 3. NOTICE. Members shall be provided a written notice no less than 30 days in advance of a proposed meeting.

SECTION 4. ORDER. All meetings of the Association shall be conducted in accordance with Robert's Rules of Order.

SECTION 5. QUORUM. The members representing 20 percent of the Active Membership shall constitute a quorum at a meeting.

#### **ARTICLE V-VOTING**

At all meetings of the members of the Association, of the Board of Directors and of any committee of the Association, votes shall be cast in person. Proxy voting shall be allowed when a duly authorized alternate, authorized by the elected member of the Board of Directors or of any committee of the Association attends as an alternate with prior notice to the IASA office by mail, e-mail or facsimile transmission. There shall be no voting by mail unless specifically provided for in these bylaws.

#### ARTICLE VI-BOARD OF DIRECTORS

SECTION 1. GENERAL POWERS. The affairs of the Association shall be managed by its Board of Directors through the development and implementation of policy and procedures.

SECTION 2. MEMBERSHIP, TENURE AND QUALIFICATIONS. Members of the Board of Directors shall include the five officers, the elected representatives from the Association's Regions, up to two at-large representatives who represent underrepresented categories of IASA membership and shall include, as ex-officio (non-voting), an IASA Active Member serving in any of the following as an AASA Officer: AASA Executive Committee Member; AASA President; AASA Past President; AASA President-Elect; or AASA Governing Board Member is a member of the IASA Governing Board or AASA Executive Committee, the Executive Director shall call a meeting of the members of the Illinois AASA Governing Board who are also IASA members, to elect from their own, a person to serve as ex-officio (non-voting) to the IASA Governing Board for a term of three years, beginning July 1, nearest the election through June 30, or until such time that another member of the IASA Governing Board becomes a member of the AASA Governing Board or AASA Executive Committee. Any person serving in an ex-officio (non-voting) capacity from AASA to IASA must be an IASA Active Member.

The Regional and At-Large, if applicable, directors shall be elected for a three-year term as normally scheduled or as vacancies occur by: (1) an election held by the membership of that Region if such election is scheduled and notice of that election is submitted in writing by March 15 by the director to the Association's Executive Director; or (2) a primary and runoff election conducted through the office of the Association by May 1.

Regional and At-Large, if applicable, directors shall assume their responsibilities on July 1 following their election and upon their signed acknowledgment of the IASA Code of Ethics policy.

To be eligible to serve as an officer or a director, a person must be an Active Member of the Association.

SECTION 3. EXECUTIVE DIRECTOR. The Board of Directors shall appoint the Executive Director and shall fix the compensation and the term of office.

SECTION 4. ORDER. All meetings of the Board of Directors shall be conducted in accordance with Robert's Rules of Order.

SECTION 5. QUORUM. A majority of the Board of Directors shall constitute a quorum for the transaction of business at any meeting of the Board of Directors.

SECTION 6. CONSULTANTS. The Board of Directors may, at its discretion, appoint persons to meet with and to serve the Board of Directors as consultants. Appointments shall be for one-year terms.

SECTION 7. REMOVAL. Any official elected to or appointed by the Board of Directors, including appointments to ad hoc committees, may be removed by the Board of Directors, whenever in its judgment, the best interest of the Association would be served. Removal shall be by a 2/3 vote of a quorum of the Board of Director's members present and voting.

#### ARTICLE VII-OFFICERS

SECTION 1. OFFICERS. The officers of the Association shall be the President, President-Elect, Secretary, Treasurer and Immediate

Past President. All officers shall be Active Members, except for the Immediate Past President, and shall have full membership rights, including the right to vote on the Board of Directors. The President, President-Elect, and Immediate Past President shall not serve as a director elected to represent one of the Association's Regions. The Secretary and Treasurer shall be a director elected to represent one of the At-Large Director is elected to an officer position, the At-Large Member shall continue to represent the State as a whole.

SECTION 2. GENERAL POWERS. The IASA Board of Directors does not govern using an Executive Committee. There may be times when, in the best interests of the Association, emergency decisions need to be made. The five duly elected officers, in consultation with the Executive Director, may meet to make decisions requiring expenditures of funds outside of the approved budget or to employ outside counsel or an independent contractor. All meetings of the officers shall include the Executive Director unless the purpose of the meeting involves actions of the Executive Director. All meetings of the officers shall be promptly reported to the full Board of Directors at its next regularly scheduled meeting. A violation of this policy shall be considered a breach of the IASA Code of Ethics and the officer's duties as a Board of Director.

SECTION 3. ELECTION AND TERM OF OFFICE. The President-Elect shall be elected annually by the Board of Directors at the last meeting of the operating year and shall hold office for one year. The President-Elect shall become President on July 1 following the term as President-Elect or when the office of the President is vacated.

The Secretary and Treasurer shall be elected to serve terms coterminous with their term as a Regional or At-Large Director. Neither the Office of Secretary nor Office of the Treasurer shall have any term limit. Election of Secretary and Treasurer shall be by the Board of Directors at the last scheduled meeting of the operating year.

Officers shall assume their responsibilities on July 1 following their elections. In the event a vacancy occurs in the office of Secretary or Treasurer, the Board of Directors is notified by the sitting officer of an eminent opening in his or her position, an election will be held by the Board of Directors at its earliest convenience to fill the unexpired term of office. The selection will be made from the members of the Board of Directors and elected by the Board of Directors.

SECTION 4. REMOVAL. Any official elected or appointed by the Board of Directors may be removed by the Board of Directors, whenever in its judgment, the best interest of the Association would be served. Removal shall be by a 2/3 vote of a quorum of the Board of Director's members present and voting.

SECTION 5. PRESIDENT. The President shall preside at all meetings of the members and of the Board of Directors. The President, with approval of the Board of Directors, shall appoint the Chair and Associate Chair(s) of each representative committee and the Chair and members of the operational committees of the Association.

SECTION 6. PRESIDENT-ELECT. The President-Elect shall assist the President in the discharge of her or his duties as the President may direct and shall perform such other duties as from time to time may be assigned to her or him by the President.

If the office of the President is vacated, the President-Elect shall become the President for the remainder of the term and shall then serve the term of President to which he or she was elected.

SECTION 7. SECRETARY. The Secretary shall sign all corporate papers and perform such other duties as required by the Association. He or she shall furnish all officers for each succeeding year a copy of the complete proceedings of the annual meetings.

SECTION 8. TREASURER. The Treasurer shall be responsible for the safekeeping of all monies belonging to the Association. He or she shall be required to sign all checks for payment of bills, except those checks drawn on revolving funds authorized by the Board of Directors to be used in the office of the Association. The Treasurer shall provide bond in the amount set by the Board of Directors for the Treasurer and such persons in the office of the Association as necessary. The bond shall be on file in the office of the Association.

SECTION 9. IMMEDIATE PAST PRESIDENT. The Immediate Past President shall fulfill duties as assigned by the President. In the event a vacancy occurs in the office of Immediate Past President, the position will be left unfilled for the remainder of the unexpired term.

#### ARTICLE VIII-EXECUTIVE DIRECTOR

SECTION 1. EXECUTIVE DIRECTOR. The Executive Director shall be the Chief Executive Officer of the Association. He or she shall attend all meetings of the Board of Directors except those at which her or his own competency or compensation is being discussed. As the Chief Executive Officer, the Executive Director shall exert leadership in promoting the official policies of the Association; shall make recommendations concerning the employment of all employees of the Association; shall prepare an agenda for all meetings of the Board of Directors along with recommendations concerning each item on the agenda; shall be responsible for investing surplus funds of the organization; shall serve as an ex-officio member without vote on all committees of the Association; and shall perform other duties at the direction of the Board of Directors.

#### ARTICLE IX-INDEMNIFICATION OF OFFICERS, DIRECTORS AND STAFF

Every director, officer or employee of the Association shall be indemnified by the Association against all expenses and liabilities, including counsel fees, reasonably incurred or imposed upon such director, officer or employee in connection with any proceeding to which such director, officer or employee may be made a party or in which such director, officer or employee may become involved by reason of being or having been a director, officer or employee of the Association, or any settlement thereof, whether or not such director, officer or employee is a director, officer or employee at the time such expenses are incurred, except in such cases wherein the director, officer or employee is adjudged guilty of willful misfeasance or malfeasance in the performance of the duties of the office or employment. In the event of a settlement, the indemnification herein shall apply only when the Board of Directors approves such settlement and reimbursement as being for the best interests of the Association. The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which such director, officer or employee may be entitled.

#### **ARTICLE X-COMMITTEES**

SECTION 1. REPRESENTATIVE COMMITTEES AND DELEGATIONS. The Association shall have four representative committees: IASA-ISBE Advisory Committee, Professional Development Committee, Membership and Communications Committee, and Governmental Relations and Advocacy Committee. The Association shall have two delegations: Governmental Strategies and Membership Strategies.

The Representative Committee shall include a representative elected from each of the Association's Regions for a three-year term, with one-third of the members being elected annually. The representative shall be elected for the three-year term as normally scheduled or as vacancies occur by: (1) an election held by the membership of that Region if such election is scheduled and notice

of that election is submitted in writing by March 15 by the director to the Association's Executive Director; or (2) a primary and runoff election conducted through the office of the Association by May 1. The representative must be an Active Member. Any Region may remove an elected representative by using the same method used to so elect that person.

The Chair and Associate Chair of each committee shall be members of the Board of Directors, appointed by the President and approved by the Board of Directors, except that the Chair of the IASA-ISBE Advisory Committee shall be the President and the Associate Chair shall be the President-Elect.

If a vacancy exists in the membership of a representative committee for more than three months, the President, with approval of the Board of Directors, shall appoint a person from the appropriate Region to complete the vacant term.

The Governmental Strategies Delegation shall include the representatives of the Board of Directors and Officers, IASA-ISBE Advisory Committee and Governmental Relations and Advocacy Committee.

The Membership Strategies Delegation shall include the representatives of the Board of Directors and Officers, Professional Development Committee, Membership and Communications Committee and Region Presidents.

The Chair of the Delegations shall be the President with the President-Elect and Immediate Past President serving as Co-Associate Chairs.

SECTION 2. OPERATIONAL COMMITTEES. The Association shall have four operational committees: Budget Committee, Bylaws Committee, Ethics and Welfare Committee, and Contract and Evaluation Committee.

The Budget Committee shall consist of five members. The Treasurer shall serve as Chair of the committee. The President shall appoint, with approval of the Board of Directors, the other four members to a term of one year.

The Bylaws Committee shall consist of three members appointed by the President, with approval of the Board of Directors, to terms of one year. The President, with approval of the Board of Directors, shall designate the Chair.

The Ethics and Welfare Committee shall consist of the President, President-Elect and Immediate Past President. The Immediate Past President shall serve as Chair.

The Contract and Evaluation Committee shall consist of the officers of the Board of Directors. The President shall serve as the Chair.

SECTION 3. SPECIAL COMMITTEES. Special Committees shall be appointed by the President, with the approval of the Board of Directors, for specific purposes.

SECTION 4. REGION PRESIDENTS. Each Region shall have the right to elect a President from the Active Members of the Region to preside over the business meetings of the Region. The term of Region President shall be set by the Region in advance of the election for the office. The Region Presidents will constitute a special committee of the Association.

The Association President shall serve as Chair of the Regional Presidents with the Association President-Elect serving as Co-Chair. Expenses of meetings called by the Chair shall be reimbursed per guidelines in the IASA Policy Handbook and charged in the budget as Board of Director expenses.

In absence of a Region President, the Director from the Region shall serve as both Director and President.

The term for Director/President shall be that term for which the person is elected to serve on the IASA Board of Directors.

Persons serving as a Director/President shall be listed in appropriate locations in Association publications.

#### ARTICLE XI-BOOKS AND RECORDS

The Association shall keep correct and complete books and records of account and shall also keep minutes of the proceedings of its members and Board of Directors and shall keep at the registered or principal office a record giving the names and addresses of the members entitled to vote.

#### ARTICLE XII-FINANCIAL RECORDS

SECTION 1. FISCAL YEAR. The fiscal year of the Association shall be July 1 through June 30.

SECTION 2. ANNUAL BUDGET. The Budget Committee shall prepare a tentative budget with estimated receipts and expenditures for the following fiscal year. The tentative budget shall be available for review by members of the Association by March 15.

The Board of Directors shall hold a hearing on the tentative budget after April 1 and prior to adoption. The Board of Directors shall adopt a budget prior to June 30 for the following fiscal year.

SECTION 3. FINANCIAL REPORTS. Financial reports shall be submitted to the Board of Directors by the Executive Director and

Treasurer on a quarterly basis during the year and shall be filed with minutes of the Board of Directors. An annual financial report shall be made at the time of the annual meeting.

SECTION 4. AUDIT. An annual audit of accounts of the Association shall be made by a certified public accountant selected by the Board of Directors.

#### ARTICLE XIII-REGIONAL STRUCTURE

SECTION 1. REGIONS. The Board of Directors shall provide for the organization and governance of Regions of the Association. The Board of Directors may modify the boundaries of any Region. The existence of any Region may be terminated following a written notice to the Region's Active Members 90 days in advance of the termination.

SECTION 2. OFFICERS. The Director of a Region shall serve as the Region President, unless the Active Members of the Region determine that another Active Member shall be elected to serve as the Region President.

SECTION 3. COMMITTEES. Each Region may have a committee concerned with each of the following issues: legislation, membership, professional development, resolutions and position statements, and advising the Illinois State Board of Education. The person elected to serve on a representative committee for the Region shall also serve as Chair of the same committee within the Region. The method of selection of regional committee members, other than the Chair, is to be determined by each Region.

#### ARTICLE XIV-REPRESENTATIVES TO ORGANIZATIONS

SECTION 1. NORTH CENTRAL ASSOCIATION OF COLLEGES AND SCHOOLS. The President, with approval of the Board of Directors, shall appoint an Active Member to the Illinois Committee of the North Central Association of Colleges and Schools in accordance with the rules and regulations of that committee.

SECTION 2. STATE TEACHER CERTIFICATION BOARD. The President, with approval of the Board of Directors, shall recommend an Active Member for appointment to the State Teacher Certification Board upon the request of the State Superintendent of Education.

SECTION 3. JOINT COMMITTEES, COMMISSIONS AND COUNCILS. The President may designate an Active Member for appointment as an Association representative to joint committees, commissions and councils upon the appropriate request. All appointments will be reported to the Board of Directors.

#### ARTICLE XV-SEAL

The corporate seal shall have inscribed thereon the name of the corporation and the words "Corporate Seal, Illinois."

#### ARTICLE XVI-LIMITATIONS AND DISTRIBUTION ON DISSOLUTION

SECTION 1. ORGANIZATION. The Association is not organized for profit. No part of its net earnings shall inure to the benefit of any private individual. No substantial part of its activities shall be the carrying on of propaganda or otherwise attempting to influence legislation. It shall not substantially participate in or intervene in any political campaign on behalf of any candidate for public office. The Association shall not accumulate out of income amounts which are unreasonable in amount or duration in order to carry out the purposes set forth in these bylaws.

Notwithstanding any other provision of these bylaws, the Association shall not conduct or carry on any activities not permitted to be conducted or carried on by any organization exempt under Section 501(c)(6) of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended, or by any organization contributions to which are deductible under Section 170(c)(2) of such Code and Regulations as they now exist or as they may hereafter be amended.

SECTION 2. DISSOLUTION. In case of dissolution of the Association and liquidation of its affairs, any money or other assets remaining after the payment of all obligations shall be transferred or conveyed to one or more educational or charitable organizations having objectives or purposes substantially similar to those of the corporation. The selection of such organization shall be determined by the Board of Directors and in every case the decision of the Board of Directors shall be final and conclusive upon all persons in any way interested.

#### ARTICLE XVII-AMENDMENTS

SECTION 1. APPROVAL. Any provision of these bylaws may be amended at an annual or special meeting of the Association provided such proposal:

- A. Has been reviewed by the Bylaws Committee;
- B. Has been reviewed by the Board of Directors;
- C. Has been submitted to the membership in writing no less than 30 days in advance of the meeting; and
- D. Receives at least a two-thirds vote of the membership present at the meeting.

SECTION 2. PROPOSALS FROM MEMBERS. Amendments may be proposed by members. Such proposed amendments must be presented to the membership for consideration provided the proposed amendment is endorsed by signature of two-thirds of a quorum of the membership and submitted to the office of the Association at least 120 days prior to an annual meeting. The Bylaws Committee and the Board of Directors are required to review the proposed amendment within 60 days and cause it to be submitted in writing to the membership at least 30 days in advance of the annual meeting. A two-thirds vote of the membership present at the meeting is required for passage.

## Vision 20/20: What's Been Accomplished

In June 2013, education stakeholders from across Illinois formed the public-policy platform Vision 20/20 in an effort to change the narrative from school districts being known for what they oppose, rather than what they stand for.

Those stakeholders include the Illinois Association of School Administrators, Illinois Association of School Boards, Illinois Principal's Association, Illinois Association of School Business Officials, Illinois Association of Regional School Superintendents and Superintendents Commission for the Study of Demographics and Diversity.



The effort identified four pillars, all focused on the overarching goal of providing a more equitable and adequate education for Illinois' 2 million school children. Those pillars are: highly effective educators, 21st century learning, shared accountability and equitable and adequate funding.

Much has been accomplished with each pillar in the past five years, but there is still more work to be done. Here is a closer look at key achievements of Vision 20/20:



Far and away the biggest success of Vision 20/20 came in August 2017, when the Illinois General Assembly passed the historic education funding reform bill, SB

1947, into law, creating the first roadmap for equitable and adequate funding for schools in Illinois.

The legislation is intended to put new money for education into the state's poorest and neediest districts—and to try to ease the state's reliance on local property taxes to pay for schools.

Here are a few of the highlights of the legislation:

- For the first time, school funding in Illinois is tied to evidence-based best practices proven by research to enhance student achievement in the classroom.
- Each school district is treated individually, with an adequacy target based on the needs of its student body. The greater the student need, the higher the adequacy target.

- New dollars will be distributed to the neediest districts first, or those furthest from their adequacy target.
- Treats students in Chicago with parity to every other school district in the state by getting rid of block grants and reconciling pension payments.

Illinois State Board of Education is releasing new tier funding for FY18 that will total approximately \$395 million statewide, including \$29 million specifically for English learners in the highest need districts.

This is a substantial investment in K–12 public education, but there is still a long way to go for each school district to reach its adequacy target, as identified in the new evidence-based model.

The goal of IASA and Vision 20/20 public policy platform is for each school district to reach 90 percent of their adequacy target in 10 years—an investment that will require at least \$5 billion.



The efforts of Vision 20/20 have yielded two significant pieces of legislation that improved teacher reciprocity for Illinois and began to address the ongoing teacher

shortage.

In July 2015, HB 2657 became law and streamlined educator licensure reciprocity agreements with other states. Here are highlights of HB 2657:

- In emergency situations, school districts can employ for up to 120 days substitute teachers who hold a professional educator license or license with stipulations that is endorsed for the grade level of instruction.
- Teachers that have completed an evidence-based assessment of teacher effectiveness or a test of basic skills in another state do not have to complete additional Illinois assessments upon initial licensure.
- Out-of-state teachers seeking licensure that have completed the same required coursework as in-state candidates need only verify program completion to receive a professional educator license.

- Endorsements for out-of-state applicants for a principal endorsement or superintendent endorsement are available to individuals who have completed an out-of-state approved education program to become a principal or superintendent, met state exam requirements and received a certificate or license endorsed in a teaching field.
- Endorsements for out-of-state applicants for a chief school business official endorsement are available to those individuals with a master's degree in school business management, finance, or accounting; completed an internship in school business management or have two years of experience as a school business administrator; met all state exam requirements; and have completed modules in reading methods, special education and English learners.

In January 2017, SB 2912, which aimed to address the teacher shortage by making it easier for educators trained outside Illinois to work here became the law. Here are highlights of SB 2912:

- Reduced the license fee for substitute teachers from \$100 to \$50.
- Created a one-year grace period for retired teachers with lapsed licenses to bring their license into good standing without fines or coursework, allowing them to substitute.
- Prevented educators who retired mid-cycle from having their licenses lapse, allowing them to substitute.
- Allowed educators licensed in other states to obtain an Illinois license through a more streamlined process, enabling Illinois State Board of Education to grant licenses based on comparable out-of-state

licenses instead of comparing preparatory programs from other states.

- Applied content area tests from other states for out-of-state licensees seeking an Illinois license.
- Created a provisional in-state endorsement on a provisional educator license with stipulations to allow candidates who have met all other requirements except passage of edTPA. This would allow candidates one additional year to pass the assessment while teaching.



In December 2017, Illinois State Board of Education released a notice of funding opportunity/request for proposals for pending state funds to expand internet connectivity in schools.

The funds would reimburse school districts for the cost of upgrading their broadband infrastructure to fiber optic technology.

The effort is part of The Illinois Classroom Connectivity Initiative, which works with school districts across the state to accelerate bandwidth upgrades through a partnership with state agencies and Education Super Highway. So far, it has helped 756 Illinois school districts, which educate more than 1.2 million students, meet the 100 kbps per student minimum connectivity goal, according to the state education board.



In August, 2015, the second piece of legislation sponsored by Vision 20/20, HB 2683, was signed and created the Illinois Balanced Accountability Model.

The new accountability model for schools stated that, in addition to using standardized test scores, schools should have flexibility to use an evidence-based framework to demonstrate student improvement and growth.

The legislation preceded Illinois' Every Student Succeeds Act plan. Some of the framework in HB 2683 was adopted in Illinois' ESSA plan, although the federal plan places more emphasis on standardized assessments.

Another focus of the Shared Accountability pillar included unfunded mandate relief. The passage of the evidence-based funding model

provided some help in this area, including:

- School boards can determine the frequency of physical education as long as it is a minimum of three days per five-day week (the state previously required daily PE). Also, allows districts to exempt on a case-by-case basis 7th through 12th graders who participate in sports.
- School districts can contract with third party drivers education vendors without requesting a waiver from the General Assembly.
- Schools now have a more streamlined process to request waivers from the General Assembly from other state mandates.

## What's Next?

In the short term, everyone needs to continue to advocate and engage

legislators for new funding for the evidence-based model. Vision 20/20 will also continue to seek both short-term and long-term

vision 20/20 will also continue to seek both short-term and long-term solutions to the teacher-shortage crisis in Illinois.

Plans are under way to conduct a revisioning meeting in early August in Springfield. The purpose of this meeting will be threefold: First, the successes of Vision 20/20 to date will be highlighted and celebrated. Second, participants will review the four pillars of Vision 20/20 and the original concepts that were adopted for further action. Additional issues within each of the four pillars will be identified for possible legislative







action. Third, participants will identify those issues that should be moved forward for additional consideration.
